PRIVACY POLICY

This Privacy Policy details the way in which **BERGNER EUROPE**, **S.L.**, (henceforth, BERGNER EUROPE) processes and protects your personal data provided through **www.artdesignfoundation.org** (henceforth known as the "website").

At **BERGNER EUROPE** we take the privacy of our users very seriously, which is why we apply General Data Protection Regulation (GDPR) (EU) 2016/679.

Carefully read this Privacy Policy to understand how **BERGNER EUROPE** processes your personal data.

1. Name and Address of the Data Controller

2. Personal data collected

We process the personal data you supply in the aforementioned email or through any of the website forms, the following in particular: Name, surname, email sent by the User.

3. Purpose of processing

Personal data are processed for the following purposes:

- 1. To correctly identify users;
- 2. To provide information requested by users;
- 3. To study and understand user needs to improve their website experience;
- 4. To perform basic administrative tasks;
- 5. At the user's request, personal data will be used to send marketing communications via email on products and services provided by **BERGNER EUROPE**. With each marketing communiqué received, the user will be informed of the procedures in place to freely oppose the processing of their data for commercial purposes. Consent granted to receive commercial

information can always be revoked, without backdating, under the provisions of Article 22.2 of the LSSI.

BERGNER EUROPE does not use personal data to create profiles and takes no automated decisions based on the same.

4. Data storage

The data provided are retained if the user does not request their deletion. This notwithstanding, the data will be stored for the legally determined period per legal, tax and accountancy law, with the date of the request for data deletion by the interested party as the point of reference.

5. Legitimisation for data processing

The legal basis for data processing is consent from the user.

6. Recipients

The personal data of users may be revealed to certain service providers. **BERGNER EUROPE** will make every effort to ensure their suppliers apply the principles of the GDPR and that these suppliers only process the data for specific purposes in line with instructions from **BERGNER EUROPE**.

BERGNER EUROPE will not tranfer user data to third parties or transfer them internationally.

Likewise, be aware that **BERGNER EUROPE** may transfer personal data at the request of the State, Court or other authorities, in accordance with the law.

7. Rights of the Interested Party

As the interested party, the user may exercise the following rights:

- a) The right to request access to their personal data: Anyone has the right to know whether BERGNER EUROPE is processing personal data relating to them. The interested parties have the right to access their personal data.
- b) The right to request rectification of their data: This means to have the Data Controller rectify without delay any personal data relating to them that is imprecise.
- c) The right to request elimination of their data (right to privacy): This means the right to have the Data Controller eliminate any personal data relating to them in all due haste in any of the following situations:
 - When the data are no longer required for the purpose for which they were obtained or otherwise processed.

- When the interested party withdraws the consent upon which processing
 was based, as established in section a) of Article 6.1 of the GDPR, or
 section a) of Article 9.2 of the GDPR, where there is no other legal basis
 for said processing.
- When the interested party opposes processing and no other legitimate reasons for processing take precedence, as established in Articles 21.1 and 21.2 of the GDPR.
- When the personal data have been processed illegally.
- When the personal data must be eliminated by legal obligation under Union or Member State Laws, as applied to the data controller.
- When the personal data have been obtained in connection with an offer for services from the information society, as detailed in Article 8.1 of the GDPR.
- d) The right to request the limiting of processing: the party will have the right to have the controller limit the processing of their data necessary by law and which are:
 - When the interested party challenges the accuracy of the personal data, within a period which allows the controller to check their accuracy.
 - When processing is illegal and the interested party opposes elimination of the personal data, preferring rather to limit their use.
 - When the controller no longer needs the personal data for the purposes of the processing, but the interested party needs them to file, exercise or defend against claims.
 - When the interested party has opposed processing, exercising their right to opposition under the provisions of Article 21.1 of the GDPR, while checking whether the controller's legitimate reasons prevail over those of the interested party.
- e) The right to data portability: Under certain circumstances, the interested party has the right to receive the personal data pursuant to them, provided to one data controller in a commonly used and machine-readable structured form and transfer them to another data controller without the former impeding said process.
- f) The right to oppose processing: the right of the interested party to oppose any personal data related to them being processed, at any time and for reasons related to their personal situation.
- g) The right to withdraw consent: the interested party has to the right to withdraw their consent for the processing of their personal data at any time.
